Agenda No.01

Panel Discussion University Curriculum & Requirements of Employment Market: GAP Analysis

Panel discussion was organized with the Alumni during Alumni Meet-2018. Objective of such discussion was to identify the gap in between curriculum & requirements of employment market. Following alumni were participated in panel discussion. Discussion was lead by Dr. R.B. Jadhav.

Almost all panelists agreed that there is gap in between what is taught in classrooms & what is required in Pharma Industry, Sales & Marketing & other areas of Pharma sector.

Senior alumnus, Mr. Sunil Karpe emphasized that basic knowledge & skills are mandatory requirements but in addition, students need to develop other expertise & skills. He put his own example that apart from Pharmacy knowledge, he learned Engineering design of Pharma plant. This facilitated him to become as an important resource person for his organization who has multiple skills. He also emphasized need of developing technical skills such as handling of modern & sophisticated instruments.

Alumnus, Mr. Ashish Pawar, working in industry, stressed that students should undergo rigorous industrial training since it matters most especially during first interview. He also appealed that institute should take advantage of 'Corporate Social Responsibility' (CSR) policy for assistance from industry.

Alumni Mr. Vaibhav Taware, Mr. Vinod Saste & Mr. Shailesh Shaha believe in Self-Employment & generating new jobs rather than searching for jobs. Mr. Vinod Saste suggested that one should start small business using government support for 'Startup'. Learn entrepreneur skills & grow slowly but certainly.

Senior alumnus, Prof. Vikram Deshmukh stressed need to bridge the gap irrespective of requirements of NBA or NAAC. He pointed that these is big space for development in Pedagogical practices, & Teachers Training.

Senior alumnus, Mr. Sujit Shinde, who is professional trainer emphasized need of developing soft skills & employability skills such as communication, organization, leadership, team working skills. He further elaborated direct link in between once earning with number & level of attainment of different skills.

Dr. R.B. Jadhav expressed vote of thanks for exploring valuable inputs from alumni & concluded the panel discussion.
